-Increasing the visibility of the social and economic importance;


- Supporting educational and training programmes;

-Favouring common actions aimed at promoting European Cultural Heritage research outside Europe.




NET-HERITAGE : MANAGEMENT STRUCTURE


Figure 1. Graphic Presentation of Work packages

NET-HERITAGE : WORKPROJECT RESULTS

WP1 - INFORMATION EXCHANGE

Lead Partner MES, Bulgaria

Systematic exchange of information and best practices concerning the management of running RTD programmes on the Protection of Tangible Cultural Heritage

RESULTS

The WP1 constructs an information system that maps strategies, research programmes and research institutions in the field of TCH protection, such as, actors, implementation, funding, duration, evaluation, dissemination. The information collected through a questionnaire and systematically stored in the information system has enabled to identify best practices (task 1.2.), to benchmark the management of research programmes (task 1.3.), and to map participation in international programmes (task 1.4.).



WP2 - INFORMATION EXCHANGE



European NET-HERITAGE observatory on cultural heritage research exchange of information

RESULTS

HERITAGE PORTAL, the main online resources developed by the project which focuses on European research applied to the protection of tangible cultural heritage. It consists of news, a databases of articles, documents and datasets,

WP 3 - STRATEGIC ACTIVITIES



Strategic activities between RTD programmes applied to the Protection of Tangible Cultural Heritage RESULTS(i)

For the first time after the EU Framework Programmes on Research this approach was followed within the Project through the **involvement of national expert panels**, which allowed to **agree on 12 research** issues of high scientific priorities. The innovation of this approach consists in the networking of research Ministries, Councils and Foundations in the field of research and cultural heritage - European Countries have common priorities and should look for common solutions in the research field of cultural heritage. -



WP 3 - STRATEGIC ACTIVITIES



Strategic activities between RTD programmes applied to the Protection of Tangible Cultural Heritage RESULTS (ii)

The list of high research priorities must be used for common programme - Cultural heritage research needs to be included in the National research agenda. - This survey can be used as a tool for an "a la carte approach" on which Joint Programming Initiatives (JPI) are based. -The list of common high priorities should be taken in due account for the definition of the 8th Framework Programme. - This survey shows the strength of the European research in the field of cultural heritage.



WP 4 - JOINT ACTIVITIES/1

Lead Partner DBU, Germany

Implementation of joint activities through the coordination between national RTD programmes on tangible cultural heritage

RESULTS (i)

This Work package was designed to follow on from the establishment of strategic activities for the implementation of joint working mechanisms and joint action plans between Partner.

Work done was increasingly connected to the JPI-process.



WP 4 - JOINT ACTIVITIES/1

Implementation of joint activities through the coordination between national RTD programmes on tangible cultural heritage

RESULTS (ii)

- In dialogue with the consortium leader and activities were targeted on supporting the success of the JPI, an option not foreseen at the time of establishment of NETHERITAGE.
- On the basis of the thorough work done by the NETHERITAGE consortium as a whole, this helped to finally **unlock immense** and **unexpected synergies for both processes**, leading to an **early joint pilot call within the JPI (by the next 12 months).**



WP 5 - JOINT ACTIVITIES/2

Lead Partner MKDN, Poland

Implementation of joint activities through the coordination of advanced training in the field of tangible cultural heritage

RESULTS

A Panel of Experts representing different backgrounds and professional areas and providing insight into various training schemes in different parts of Europe supported the WP5 team in the analysis of existing training possibilities.

The experts made a number of recommendations, which form a Model Framework for Advanced Education (Del. 5.1)



WP 5 - JOINT ACTIVITIES/2

Lead Partner MKDN, Poland

Implementation of joint activities through the coordination of advanced training in the field of tangible cultural heritage

RESULTS

- A Declaration of Support for the recommendations was prepared (Del. 5.2). It was decided that to impact heritage science advanced education two stakeholder groups should be taken into consideration one concerns decision makers and the other training institutions.
- A very important part of WP5 activities is dissemination the approach proposed through **pilot courses** and short conferences (deliverable 5.3).


